

Terms and Conditions

- Select Plan Pests Covered: Ants, Spiders, Roaches (American, German & Oriental), Centipedes, Earwigs, Millipedes, Silverfish, Beetles, Crickets, Moths (Indian Meal Moth & Clothes Moths), Boxelder Bugs, Stink Bugs, Asian Beetles, Carpet Beetles, Grain Beetles, New House Beetles, Mites, Springtails, Bees, Wasps (Cicada Killer & Yellow Jackets), Hornets, Weevils, Mice & Rats.
- Preferred Pest Control agrees to provide the necessary regular service to manage the pests listed above. If monthly fees are paid and regular service program is followed, Preferred Pest Control will provide any additional service necessary (where live infestations are found) at no additional charge to the customer.
- Mosquito/Tick/Flea program: (if selected) includes seasonal treatments. The program will not eliminate all mosquitoes/ticks/fleas, it will only reduce numbers present. Should you feel you are seeing too many mosquitoes, extra treatments will be made at no cost, however, treatments cannot be less than two weeks apart.
- Termite protection: (if selected) is covered by a separate re-treatment only service agreement and coverage only begins after inspection and termite control service agreement has been completed, signed and bait stations installed. Price is based on the home having no active termite infestation. Should activity be found prior to start of service an additional charge may be incurred for treatment of infestation
- Chemical Sensitivity: If customer or other occupants of the structure(s) believe they are or may be
 sensitive to pesticides/termiticides or their odors, Customer must notify Company in writing, in
 advance of treatment, including whether Customer or other occupants have consulted with a
 medical doctor or other healthcare provider regarding such sensitivity. Failure to provide notification
 represents Customers assumption of risk and waiver against Company in connection with sure
 sensitivity.
- Late payment: A late fee of 1.5% will be applied to your account if your balance is not paid within 30 days. Preferred Pest Control at its option may discontinue service and start collection proceedings.
- Renewal & Price: This agreement shall be for an initial period of one year and will renew itself annually unless either party cancels this agreement by giving thirty days written notice. Preferred Pest Control reserves the right to increase the service charge after the first year of the agreement.
- **Liability:** ANY LIABILITIES ARISING FROM THIS AGREEMENT SHALL BE RESTRICTED TO THE PURCHASE PRICE OF THE TREATMENT.
- PAYMENTS: Monthly payments are to be made by automatic credit card payment only. We only
 accept credit or debit cards for monthly charges. Payments are processed on 1st of month.
 Cancellation during the month will take effect 1st of next month, current month will not be refunded.
